Food truck/ food vendor set up will be in the parking lot previously used for the farmer's market at Otsiningo Park. Vendors can start setting up at 7:00 am. **The event is open for vendors from 10 am-7:30 pm**

Fees: **\$150 EARLY BIRD/ \$225 Regular** deadline. Payment and proof of insurance will be due on April 5, 2022 Early Bird/ May 27, 2022 Regular deadline.

Important Reminders

- **Vendors are required to carry liability insurance in the amount of \$1M. Please provide proof of insurance and sign and submit the hold harmless document below with your application.**

Venue: County of Broome

(Insurance certificate must state "THE COUNTY OF BROOME IS NAMED AS AN ADDITIONAL INSURED ON A PRIMARY NON-CONTRIBUTORY BASIS").

- You are responsible for controlling your staff, and all vendors must conduct themselves in a courteous, polite and professional manner. All vendors must abide by the rules & regulations of Broome County Department of Parks, Recreation and Youth Services. You are responsible for being an informed participant and following all Festival Rules & Regulations.

Indemnification and Insurance: You are solely responsible for any injuries, accidents, or losses which may be sustained as a result of your vending operations at The Holistic Health & Wellness Fair presented by Wellness Centered, LLC at Otsiningo Park in Binghamton, NY. This coverage will provide at least a \$1,000,000 General Aggregate limit and \$1,000,000 per occurrence limit and be provided through an insurance carrier rated A or better. VENDOR shall name the County of Broome.
